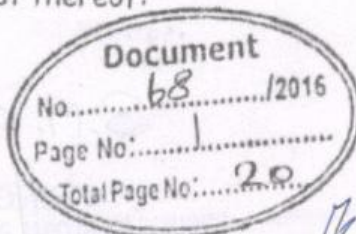
DECLARATION OF TRUST:

6. The Benefits of the Trust are open to all in the society at large irrespective of caste, creed, religion, sex, etc.,

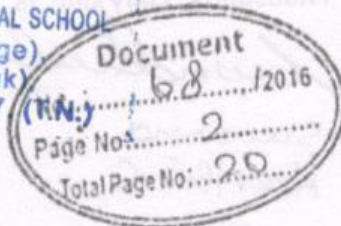

7. THE TRUST FUNDS:


The following shall constitute the funds of the trust:

8. OBJECTS OF THE TRUST:

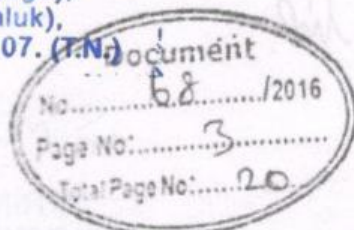
The TRUST is hereby formed as a Non-Profit Organization with its purpose & objectives stated hereunder:



- c) To provide scholarship and other assistance to students, and to grant awards for students by conducting competition or otherwise.





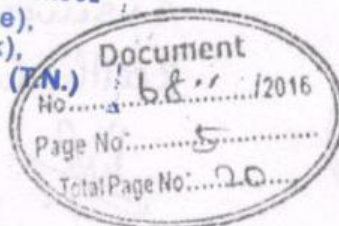
10. Officers of the Trust:

If the Chairman is absent from any meeting of the Board of Trustees and the Vice-Chairman present, she shall preside at the meeting. The Vice-Chairman may assist the Chairman with duties as delegated by the Chairman.
- iii) Secretary: Keerthi C shall be the first secretary for life or till she relinquishes that post. The secretary shall keep and maintain minutes of all the Board of Trustees. The secretary shall be responsible for maintaining and safe custody of all the records and assets of the Trust.

She should ensure the timely auditing of accounts.

11. POWER OF THE CHAIRMAN:

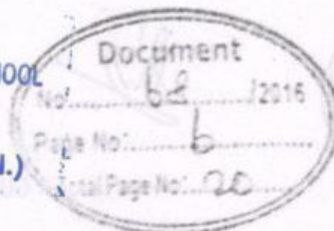
- 11.1 Chairman of the Trust shall be Executive Head of the Trust. His advice shall be final in all matters pertaining to the administration of the Trust. He shall preside over all meetings, conduct the meetings in a democratic manner.
- 11.2 He is empowered to nominate/constitute separate groups of executives/ directors to assist in maintaining / managing the normal routine activities of the Trust according to the nature/necessities and needs for education and service etc.,
- 11.3 Chairman of the Trust is a head who will be the chief administrator. After the founder Chairman, the next chairman shall be elected by majority of the trustees and the tenure of the Chairman shall be for such period as may be decided by the trustees from time to time.
- 11.4 Chairman has got full authority either to admit or reject any resolution to be brought by the trustees before the Trust Board.

12. GENERAL POWERS OF THE TRUSTEES

- 12.1 The Trustees shall be entitled for reimbursement of all expenses incurred by them including travelling expenses for the purpose of attending the meeting of the trustees and also indemnified in respect of all acts done in the course of carrying the activity of the trust and its legitimacy.
- 12.2 The Board of Trustees, shall have full, absolute and complete powers in the day to day administration and execution of the trust and may delegate the power to managing trustees, if any.

13.1 The Board of Trustees, hold power to manage the affairs of the Trust and to formulate policies, rules and Trust Deed for effective management of the Trust and to amend the Trust Deed or other rules for effective management of Trust, from time to time to meet all the exigencies of the proceedings laid down in the initially formulated Trust Deed. The affairs of this Trust shall be managed by its Board of Trustees.

13.4 The Trustees may receive voluntary contributions by way of gifts or grants from in cash or other mode including any asset, towards the corpus of the Trust or towards the capital expenditure of the Trust and the same when received, shall become part and parcel of management of the Trust. The Trustees may also receive such donations for purposes of meeting the recurring expenditure of the trust.

13.5 Without prejudice to the generality of the powers vested in the Trustees and notwithstanding anything contained in the Indian Trust Act, 1882 and without repugnance and subject to the provisions of the Income Tax Act, 1961 & Income Tax Rules, 1962 and any modifications thereof, the Trustees shall have the following specific powers:

a. To acquire lands, build upon, pull down, rebuild, use or otherwise cultivate or improve, sell or dispose of any land, building or premises for the use of the Trust, and to acquire other movable or immovable benefits of immovable properties.

b. To take any properties on lease or hire.

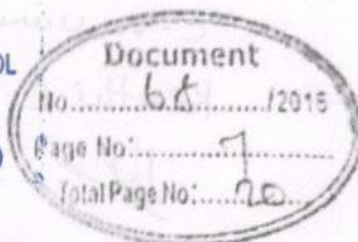
c. To let on hire or lease and transfer any movable or immovable properties not immediately required by the Trust.

14. GENERAL PROVISIONS:

14.1 Indemnity:

14.4 Policies and Procedures:

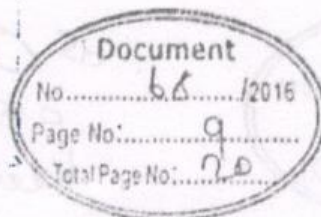
The Board of Trustees will establish the policies and procedures necessary for the effective and efficient operation of the Trust.

14.8 Removal / Resignation of trustees:

Any of the trustees of the Board shall cease to be a trustee:

- i) Upon Death.
- ii) If he resigns from his trusteeship.
- iii) If a resolution to the effect that his act or the continuance of a trustee is detrimental to the trust, has been passed with not less than two-third majority of the total members of the Board of the trustees.

14.9 Vacancies:

A vacancy in any position arising on death, resignation, removal may be filled by the Board for the unexpired portion of the term.

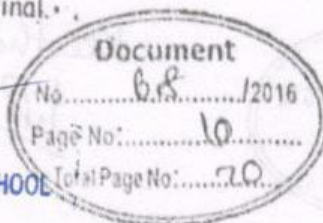
14.10 Compensation.

15. BANKING ACCOUNTS

The Trust Board shall open one or more Bank accounts in the name of the Trust. Such alterations or modifications shall not be repugnant to the provisions of income-tax and shall be carried out only with the approval from Commissioner of income-tax or other authorities under the income tax Act.

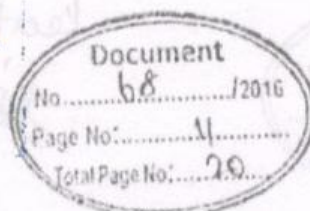
17. BOOKS OF ACCOUNTS & AUDIT:



The Trust shall invest its income available for investments from time to time in specific mode of investments as per Section 11(5) of the Income Tax Act, 1961.

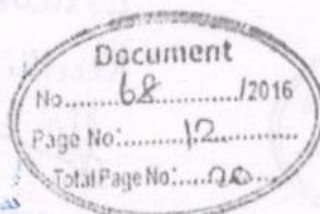

19. Dissolution:

- i) If the Trust hereby constituted fails for any reason in the opinion of the majority of the Trustees of this Trust, the net assets of the Trust both movable and immovable shall be handed over to any public charitable trust as decided by the majority of the trustees, which has similar objects.
- ii) In the event of closure or winding up or dissolution of the trust the assets remaining as on the date of dissolution shall under no circumstances, be distributed among the trustees, but the same shall be transferred to another Trust, society or institution which has similar objective registered under Section 12AA of the Income-Tax Act, 1961.
